



1. Réamhráiteas – *Introduction*

Is iad aidhmeanna an Pholasaí Úsáid Inghlactha seo ná:

The aims of this Acceptable Use Policy are :

- a chinntiú go bhfaighidh daltaí Gaelscoil Inse Chór buntáistí as na deiseanna foghlama, as acmhainní idirlíon na scoile ar bhealach sábháilte agus éifeachtach.

To ensure that pupils in Gaelscoil Inse Chór will benefit from learning opportunities offered by the school's Internet resources in a safe and effective manner.

- comhairle agus treoracha a thabhairt maidir le húsáid inghlactha don fhoghlaim, don mhúinteoireacht agus don chumarsáid atá in oiriúint do chomhphobal na scoile ina iomlán (daltaí, foireann, tuismitheoirí, cuairteoirí/cainteoirí)

To give guidance and direction for the acceptable use of ICT for teaching, learning and communication as appropriate for amembers of the school community (pupils, staff, parents and visitors/speakers)

- Go bhféachtar arna háiseanna TFC agus rochtain ar an idirlíon mar acmhainní a thacaíonn leis an bhfoghlaim agus leis an múineadh agus go dtuigtear go bhfuil cearta agus freagrachtaí ag an gcomhphobal scoile an acmhainn seo a úsáid i gceart.

That provision of ICT resources and access to the Internet supports teaching and learning with rights and responsibilities for all users.

Chuir an coiste TFC an polasaí athbhreithnithe seo le chéile i mí Feabhra 2023 tar éis dul i gcomhairle le foireann na scoile, Cairde na Scoile agus an Bord Bainistíochta. Tá sé i gceist go ndéanfar athbhreithniú rialta ar an bpolasaí seo ag freagairt do theicneolaíocht nua agus riachtanais nua a eascraíonn as an teicneolaíocht nua.

The ICT committee reviewed this policy in February 2023 following consultation with staff, Cairde na Scoile and the Board Of Management. It is envisaged that this policy will be reviewed on a regular basis in a responce emerging technologies and issues arising.



2. Réasúnaíocht. *Rationale.*

Aithnítear i nGaelscoil Inse Chór go dtugann teicneolaíocht faisnéise agus cumarsáide (TFC) deiseanna foghlama, deiseanna cumarsáide agus réimse leathan scileanna a chabhróidh lenár ndaltaí don todhchaí. Cuirfidh TFC le h- eispéireas foghlama na ndaltaí agus na foirne.

Leagtar amach sa Pholasáí Úsáid Inghlactha seo treoracha agus freagrachtaí do chomhphobal na scoile (daltaí, múinteoirí, tuismitheoirí agus cuairteoirí) agus TFC in úsáid d'aon ghníomh a bhaineann leis an gcuraclam nó aon ghníomhaíochtaí scoile.

Gaelscoil Inse Chór recognises that access to Information and Communication Technology (ICT) gives our pupils enhanced opportunities to learn, engage, communicate and develop skills that will prepare them for many aspects of life as well as enhancing the learning experience for both pupils and staff.. This Acceptable Use Policy outlines the guidelines and behaviours that pupils, parents, staff and approved visitors/speakers etc are expected to follow when using ICT technologies for curricular and any other school related activities

Agus TFC á úsáid i nGaelscoil Inse Chór, tá sé mar fhreagracht ag gach ball de chomhphobal na scoile :

When using ICT in Gaelscoil Inse Chór, all members of the school community are expected :

- Aire a thabhairt do gach uirlis TFC agus cloí le treoracha an pholasaí seo.

To take good care of all school ICT equipment and use it responsibly in accordance with school policy.

- Meas a léiriú ar a chéile i gcónaí.

To treat others users with respect at all times.

- Meas a léiriú ar chearta príobháideachais gach ball den chomhphobal scoile.

To respect the right to privacy of all members of the school community.

- Meas a léiriú ar chóipcheart agus aitheantas a thabhairt do chruthaitheoirí agus áiseanna ar líne á n-úsáid.

To respect copyright and acknowledge creators when using online content and resources.

- Gan aon drochiompar nó mí-úsáid a bhaint as an bhfearas TFC a tharraingeodh droch-chlú ar an scoil/ a thabharfadh drochainm don scoil nó d'aon phearsan sa chomhphobal scoile

Not to engage in behaviours or misuse ICT resources in a manner that would bring the school or any individual in the school community into disrepute.

Cuirtear na straitéisí seo a leanas i bhfeidhm i nGaelscoil Inse Chór chun úsáid shábháilte an idirlín a chur chun cinn.

Gaelscoil Inse Chór implements the following strategies to promote the safe use of the internet:

- Cuirfear oiliúint ar fáil maidir le sábháilteacht ar líne mar chuid den churaclam OSPA. Úsáidfear réimse ceachtanna óna na cláir Bí Sábháilte, Mo Féinín, /Webwise sna ranganna sinsearach.

Pupils will be provided with education in the area of internet safety as part of the SPHE curriculum. This includes but is not limited to Stay Safe Lessons and My Selfie/Webwise resource in Senior Classes.

Workshops for pupils on Online Safety and Cyber Bullying are organized for pupils and parents regularly as recommended in the school's Anti-Bullying Policy.

- Aitheantas a thabhairt do Lá le haghaidh idirlíon níos Sábháilte i mí Feabhra gach bliain.

Safer Internet Day will be acknowledged in Senior Classes in February each year.

- Cuirfear forbairt ghairmiúil leanúnach ar fáil don fhoireann maidir le sábháilteacht ar líne, cumarsáid ar líne agus teicneolaíocht TFC

School staff will be provided with continuing professional development in the area of internet safety and online communication and ICT technologies

Féachtar ar úsáid agus rochtain idirlín mar acmhainn agus mar phribhléid scoile. Muna gcomhlíontar polasaí úsáid inghlactha na scoile (PÚI)tarraingeofar siar an phribhléid seo.



Internet use and Access is considered a school resource and privilege. If the school's Acceptable Use Policy (AUP) is not adhered to this privilege will be withdrawn

Ní cheadaítear tiomántán seachtrach nó cipín cuimhne (USB) a úsáid ar scoil.

External drives/ USB storage devices are not permitted to be used in school.

Tá an t-idirlíon ar fáil go forleathan sa scoil Tá 28 iPad a fheidhmíonn ar an gcóras Wi-Fi scoile.

The Internet is widely accessible in the school there are 28 iPads connected to school Wi-Fi.

Students will use the Internet for educational purposes only with permission and under the supervision of the teacher.

Pupils will use search engines suitable for children (Kidrex, Kiddle, Safe Search Kids etc)

- Ní rachaidh na daltaí chuig suíomh idirlín ar a mbeidh ábhair ghraosta, mídhleathacha, fuatha nó a bheidh míchuí ar bhealach eile. Má théann dalta ar bith ar shuíomh mar sin de thimpiste ní mór é a chur in iúl don mhúinteoir láithreach bonn.

Pupils will not intentionally visit internet sites that contain obscene, illegal, hateful or otherwise objectionable materials – pupils must report accidental accessing of any inappropriate sites etc to teacher immediately.

Tá scagaire ábhair Leibhéal 2 de Scagaire Ábhair Líonra Leathanbhanda Scoileanna an Lárionad Náisiúnta do Theicneolaíocht san Oideachas (NCTE) á úsáid ag Gaelscoil Inse Chór. Cuireann an scagadh seo cosc ar leas mhí-oiriúnach a bhaint as an bhfearas. Ní



cheadaítear do pháistí iarracht a dhéanamh, an scagadh seo a sheachaint, / dul thart ar an scagadh seo, obair timpeall ar an scagadh seo

Gaelscoil Inse Chór has content filtering at level 2 of the Schools Broadband Network Filter (NCTE). This filter prevents misuse of technology. Children are not permitted to attempt to bypass School Content Filtering.

R-phost *Email.*

Níl cead ag daltaí seoladh r-phoist pearsanta a úsáid ar scoil. Cruthaítear seoltaí nó seoladh ranga i ranganna faoi stiúir agus maoirsiú an mhúinteora.

Children are not permitted to use personal email addresses in school. Class emails may be created and monitored by the teacher

Na Meáin Shóisialta *Social Media.*

Ní cheadaítear do dhaltáí na meáin shóisialta nó an t-idirlíon a úsáid chun cur isteach (ciapadh, masla, mí-úsáid, clúmhilleadh) ar aon bhall de chomhphobal scoile (daltaí, a dteaghlach, foireann scoile). Tá cumarsáid in scoile agus taobh amuigh den scoil san áireamh anseo. Ní cheadaítear eolas a roinnt ar na meáin faoi bhall ar bith den chomhphobal scoile.

Social media: Pupils must not use social media in any way to harass, insult, abuse or defame any member of the school community (pupils, their families and staff). This applies to both in school and out of school online communication. Pupils must not post or share information about any members of the school community on social media.

Níl cead ag daltaí cairdeas a lorg le haon bhall den fhoireann scoile ar na meáin shóisialta.

Pupils must not seek to “friend” any member of school staff using any social media facility

The use of all instant messaging services or apps including What's App or Snapchat etc. Is strictly forbidden in school or on any school device.

Fóin phóca agus Gléasanna Leictreonacha *Mobile Phones and electronic devices.*

Ní cheadaítear do dhaltáí fóin phóca, uaireadóir cliste (an cumas acu dul ar líne/taifead a dhéanamh), nó gléasanna leictreonacha a úsáid ar shuíomh na scoile,



ag aon ghníomhaíocht scoile taobh amuigh den suíomh scoile nó ag gníomhaíochtaí seach-churaclam.

Pupils are not permitted to use mobile phones, smart watches Capable of going online/recording images or electronic devices on the school premises, on out of school or extracurricular activities.

An Cód Deonach

Iarrann an cód ar thuismitheoirí stop a chur le fón cliste a fháil go dtí go mbeidh an Bhunscoil críochnaithe ag na páistí agus go mbíonn treoir faighte acu maidir le húsáid chuí a bhaint astu.

The code asks parents to hold off on getting Smart phones until the children have completed Primary School and have received guidance on how to appropriately use the

Taifead Íomhánna agus Físeán *Recording of Images and Video*

Ní cheadaítear do duine ar bith íomha/taifead a ghlacadh nó a a roinnt ar-líne d'aon bhall den chomhphobal scoile laistigh agus lasmuigh den scoil Tá cead íomhanna a ghlacadh/taifead a dhéanamh faoi chúram an mhúinteora agus ar fhearas scoile amháin. Níl cead ag aon bhall den chomhphobal scoile taifead a dhéanamh den chomhphobal scoile ar ghléas pearsanta nó ar ceamara

Pupils are not permitted to take or share images/ recordings online of any member of the school community either in school or out of school. Recording of images and videos may be taken using school equipment under the direction of the teacher. Members of the school community are not permitted to record images or videos on personal devices or cameras

Faightear cead ó thuismitheoirí/caomhnóirí ag am chlárúcháin grianghraif dá bpáistí a fhoilsiú ar shuíomh gréasáin na scoile. Seans go n-iarrfaidh múinteoir ar pháiste nach bhfuil an cead sin tugtha, seasamh amach as an ngrianghraf/físeán a bheidh le dul ar shuíomh gréasáin na scoile. Ní chuirfear ainm an pháiste le grianghraf riamh Is féidir grianghraif a ghlacadh d'aon pháiste agus dá chuid oibre más ar bhonn taispeántas scoile atá sé. Cuirtear foireann na scoile ar eolas faoi pháistí gan cead íomhánna srl a uaslódáil ar shuíomh gréasáin na scoile tríd Aladdin.

Permission is obtained from Parents/guardians at enrolment to allow photographs or their child(ren) to be published on the school website. Pupils without this permission may be asked to step out of photos/videos etc that are intended for the school website. Children's names will never be displayed with photos. Photographs may be taken of all children and/or their work for internal school display only. Staff will be notified of children who do not have permission for their image/work to be uploaded on school website via Aladdin.

Not to use social media (including group messaging services e.g What's App, Messenger etc or the Internet in any way to harass, insult, abuse or defame any member of the school community (pupils, their families and staff).

- Gan íomhánna/ físeáin de dháltaí nó baill foirne Gaelscoil Inse Chór a uaslódáil ar na meáin shóisialta. Tá ceolchoirmeacha, searmanais reiligiúnda, imeachtaí spóirt san áireamh.

Not to upload images /videos featuring pupils or staff members of Gaelscoil Inse Chór to any social media platform. This includes school concerts, religious ceremonies and sporting events etc.

- Gan íomhánna de bhall ar bith den chomhphobal scoile a ghlacadh, a roinnt nó a dháileadh gan cead ón mball den chomhphobal.



Not to take, share, or distribute images of any member of the school community without their expressed permission.

- Gan a bheith páirteach leis na meáin shóisialta nó aon fhoirm den teicneolaíocht cumarsáide a d'fhéadfadh droch-cháil a tharraingt ar Gaelscoil Inse Chór

Not to engage in social media or any form of communication technology which could bring Gaelscoil Inse Chór into disrepute,

- Táthar ag súil go mbeidh tuismitheoirí/caomhnóirí freagrach as a bpáistí agus iad ag baint úsáide as TFC agus gléasanna leictreonacha (Fóin phóca san áireamh) agus go ndéanfaidh siad monatóireacht ar an líon ama a chaitheann a bpáistí ar líne, na suíomhanna a bhíonn in úsáid, agus iompar a bpáistí ar líne taobh amuigh den scoil.

Parents/ Guardians are expected to take responsibility for their children's use of ICT and electronic devices (including mobile phones) and should monitor the amount of time spent online, sites visited and their children's online behaviour outside of school.

Ní féidir le h-udaráis na scoile a bheith freagrach as iompar dhaltaí ar líne agus iad taobh amuigh de thimpeallacht na scoile. School authorities cannot be responsible for pupil online behaviour that arises outside of the school environment. However, the school will co-operate in so far as possible with parents/guardians in dealing with reports of inappropriate online incidents that impact on the wellbeing of pupils and/or staff. The school Code of Behaviour and/or Anti Bullying Policy may be used in dealing with such cases.

To ensure that children are only on age-appropriate social media sites. The Staff recommend that pupils are not on Facebook, Snapchat or Instagram. They also recommend that they are not on YouTube alone and that they don't have their own YouTube account.



- Tá leathanach Facebook ag Cairde na Scoile Gaelscoil Inse Chór atá faoi údarás Bhord Bainistíochta na scoile. Úsáidtear é chun ócáidí scoile a fhógairt agus dó sin amháin.

Cairde na Scoile have a Facebook page under the authority of the Board Of Management. This is used solely to promote school events,

- Is léir go bhfuil grúpaí Whats App i measc tuismitheoirí ranga. Moltar iad seo chun eolas ranga bunúsach a roinnt. Ní ghlacfar le plé mailíseach ar na grúpaí seo dírithe ar aon bhall den chomhphobal scoile. Moltar a leithéid a thuairisciú chuig príomhoide na scoile ionas gur féidir comhairle cuí a lorg ar conas déileáil leis.

It is clear that there are a number of class What's App groups among the parents. These are an effective way of sharing basic information. Malicious comments directed at any member of the school community will not be tolerated in these groups. It is recommended that the Principal be informed of any such activity to deal with it.

It is recommended that problems encountered during the school day are not addressed on these groups. If any parent has any concerns, he/she should contact the office to arrange an appointment in order to discuss the matter with a view to resolving any issue.

School equipment is used for educational purposes only. Staff may use Internet for personal use outside of class time.

All images and recordings of the school community must be taken on school devices only.

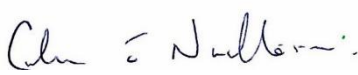
